2. BACKGROUND

Universal Health Coverage (UHC) is a key target under the Sustainable Development Goal (SDG) for health (SDG3). While ensuring access to care is an important goal in its own right, it is also instrumental in the overarching goal of reducing mortality. However, countries have faced significant challenges in achieving the health sector goal of UHC. Gaps are particularly large for health care related to non-communicable diseases (NCDs), and the SDG targeting a reduction in global NCD-related mortality (SDG 3.4) has remained stubbornly out of reach.

NCDs have emerged as a priority in many regions. This is notably visible in recent efforts to refine NCD priorities. The NCD Poverty Network has supported the development of national commissions across more than 20 low- and middle-income countries to articulate national priorities. The Bergen Centre for Ethics and Priority Setting in Health (BCEPS) has explicitly linked

priority setting and UHC and is working with stakeholders across several countries, including Nepal, to strengthen NCD service delivery through the articulation of a UHC benefit package that takes into account the efficiency, equity and cost implications of NCD care delivery. It is important to develop plans to generate actionable information on the current status of high-priority clinical services, as well as recommendations on how these services might be reorganized to achieve UHC objectives by efficient and effective use of the available resources. In addition to developing locally contextualized recommendations, Centre for Integration Sciences (CIS) is also working with the University of Bergen to extend FairChoices, an interactive online tool offering decision support to national policy makers.

As part of this work, the CIS with collaborate with the Kathmandu Institute of Child Health (KIOCH) to examine NCD care delivery in Nepal. KIOCH oversee the development and implementation of the relevant research activities, and will lead in the development of a report detailing recommendations on how existing NCD services can be expanded. The work highlight the core principles of integration science: leveraging shared competencies in care delivery to optimize the delivery of pro-poor care. In addition to providing actionable advice to national stakeholders, data will serve as an input to the FairChoices platform.

By employing Time Driven Activity-Based Costing, it is possible to gather cost data on the delivery of NCDs and other crucial healthcare services at the facility level with the aim of using this data to efficiently allocate resources, enhance monitoring efforts, and boost effectiveness. So far, little is known of the details related to the delivery of most of the targeted interventions – including the overall level of delivery and how such care might be organized within facilities. This study will use a structured approach to fill this gap.

KIOCH is a not-for-profit organization registered with the Government of Nepal (GoN), with the objective of delivering high-quality and affordable multispecialty care to children across Nepal by building a comprehensive pediatric care facility within the nation and conducting research activities to act upon preventable deaths due to NCDs.

3. PURPOSE:
