## 1. Purpose of Document

The purpose of this Terms of Reference (ToR) is to recruit Program Officer who will support "Strengthening Primary Health Care and Referral System for Prevention and Management of NCDs including Neurodevelopmental Disorders among Children and Adolescents in Nepal (C&A PEN-Plus)" and other works of KIOCH. This document will provide the background, conditions, and responsibilities of the position.

## 2. Background

"Strengthening Primary Health Care and Referral System for Prevention and Management of NCDs including Neurodevelopmental Disorders among Children and Adolescents in Nepal (C&A PEN-Plus)" compliments the Package of Essential Non-Communicable Diseases Interventions Plus (PEN-Plus) program that has been initiated in Nepal. PEN-Plus is an integrated service delivery model that provides quality services to severe NCDs at the first-level referral (district) hospital and it addresses more severe NCDs and NCDs prevalent among the poor such as type 1 diabetes, advanced rheumatic heart disease, and sickle cell disease. This model aims at progressive decentralization and integration of chronic care of NCDs at the lower levels of the health system through training and ongoing

mentorship, eventually contributing to the reduction in the burden of NCDs, protecting the vulnerable population from financial hardship, and maintaining the continuum of chronic NCD care.

KIOCH is a not-for-profit organization registered with the Government of Nepal (GoN), to deliver high-quality and affordable multispecialty care to children across Nepal by building a comprehensive pediatric care facility within the nation and conducting research activities to act upon preventable deaths due to NCDs. KIOCH is implementing partner for the PEN-Plus Partnership Project in 3 districts in Nepal in partnership with the Ministry of Health and Population.

The C&A PEN-Plus is a program aimed at establishing integrated health service delivery for severe or advanced chronic NCDs in children and young adults at the first-level referral hospital, built upon the PEN-Plus. The C&A PEN-Plus incorporates integrated care teams to provide chronic care for severe NCDs including Type 1 Diabetes, Rheumatic Heart Disease (RHD), neurodevelopment disorders and birth defect at first-level (district) hospitals. It is assumed that this approach, with some modification based on the context of the Nepalese health system and practices, can advance toward universal health coverage (UHC) for NCDs by strengthening NCD services and the referral chain, by capacity-building training to bridge skilled human resource gap, and by providing best avenues to support vulnerable patients and their families. This approach will also expedite the process of decentralizing NCD service delivery at the first-level referral hospitals in regard to the common NCDs among children and adolescents.

#### 3. Purpose:

The Program officer will be responsible for the execution of the project deliverables at C&A PEN-Plus sites, facilitation of the project meetings and pieces of training, conducting monitoring and evaluation of the project implementation, and reporting project progress and issues. S/he will directly report to the project coordinator.
